Membership Rules & Regulations

1. Membership Fee:

- If a member fails to attend or report to the academy for a continuous period of 6 months or more without prior intimation, the membership will be considered inactive or abandoned. The academy reserves the right to terminate such membership without refund.

2. Coaching Fee Payment:

- Fees must be paid in advance according to chosen packages.
- Late fee will be imposed if fees are not paid by the specified date.

3. Membership Eligibility:

- Membership is subject to approval by the academy's management.
- A valid doctor's certificate may be required at the discretion of the management.

4. Complete Application:

- Membership application must be fully completed.
- Incomplete applications will be considered void.

5. Sports Equipment:

- Members are responsible for their own sports equipment and accessories.
- The academy will not provide personal equipment.

6. Admission Guarantee:

- Submission of membership application does not guarantee admission to the academy.

7. Responsibility & Mishaps:

- The academy is not liable for any accidents or incidents during practice or activities.

- If submitted information is found to be incorrect, membership may be revoked.
- No refunds of admission fees or charges will be given.

9. Membership Entitlement:

- Each membership entitles only the individual member.
- Match fees are separate and not included in coaching fees.

10. Practice Ground Availability:

- Practice ground availability is subject to unforeseen circumstances, and the academy shall not be held liable for any temporary unavailability.

11. Property & Profit:

- This is a service-based membership for training and participation only.
- Members have no ownership, stake, or legal rights over academy property, facilities, brand, or operations.
- Membership does not entitle members to any share in profits, assets, or decision-making.

12. Identification & Dress Code:

- Members must wear academy uniform as instructed.

13. Prior Approval for Matches:

- Approval from branch coach is needed for participating in matches.
- Unauthorized club or tournament registration may result in actions by the academy.

14. Media Usage:

- The academy reserves the right to use photographs/videos for advertising purposes.

15: Legal & Disciplinary Action

- Management can terminate membership without prior notice.
- Termination decisions are final and cannot be delegated to others.
- In case of any misconduct, breach of discipline, damage to academy property, or violation of academy rules, necessary action may be taken including suspension or termination of membership. Legal action may be initiated in severe cases.

16. Leave Policy:

- Members must submit a written leave application to the branch head coach in case of extended absence.
- Only if the leave period exceeds 10 consecutive days and prior approval is obtained, the fee package duration may be adjusted or extended accordingly.
